

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.bucketsforbenefit.com](http://www.bucketsforbenefit.com), and Organic Creations, LLC DBA Buckets for Benefit and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Organic Creations, LLC DBA Buckets for Benefit include [www.bucketsforbenefit.com](http://www.bucketsforbenefit.com) and Buckets for Benefit. The Buckets for Benefit website is a Information and registration for laundry detergent fundraising site. By using the Buckets for Benefit website, you consent to the data practices described in this statement.

## Collection of your Personal Information
